DOG BREEDING ESTABLISHMENTS ACT, 2010

CLOSURE NOTICE

To: Mr Micheál O'Reilly (otherwise known as Michael O' Reilly) of 21 Primrose Banks, Cois Máigh, Mogeely, in the County of Cork, Eircode P25K693

Cork County Council in exercise of the powers conferred on it by Section 21(1) of the Dog Breeding Establishments Act, 2010 ("the Act"), hereby directs that the Dog Breeding Establishment identified in Part 1 of the Schedule ("The Establishment") be immediately closed until the earliest of:

- (i) an Order to contrary effect by a Court of competent jurisdiction;
- or
- (ii) further written direction by Cork County Council

This notice is made for the particular reasons set out in Part 2 of the Schedule.

- You may appeal this notice not later than seven days after the service of the notice (or for such a longer period as the district court may, for good and sufficient reason determine) to a Judge of Midleton District Court, Midleton, in the County of Cork.
- You are required to immediately cease breeding or keeping dogs at The Establishment and take such measures as directed to enable the rehousing, at your own expense, of all dogs being kept for the time being at The Establishment.
- You are required to arrange for the rehousing of the dogs at your own expense per Section 21 of the Act. All dogs must be microchipped and registered in accordance with the Microchipping of Dogs Regulations (S.I. No. 63 of 2015) and records of all sales/ transfers must be available upon request to an authorised officer.
- If you contravene this closure notice, you shall be guilty of an offence.

Part 1 ("The Establishment")


The Dog Breeding Establishment operated by Mr. Micheál O'Reilly (otherwise known as Michael O'Reilly) situate at Killnamuckey, Mogeely, Castlemartyr, in the County of Cork, Eircode P25 WR92

Part 2 Particular reasons for making of Order

Cork County Council is satisfied that the operation of The Establishment poses a serious and immediate threat to animal welfare and/ or public health due to non-compliance with the requirements of the Act, associated 2018 Guidelines and is operating an unregistered Dog Breeding Establishment.

Non-compliance with the Act and Guidelines included lack of cleanliness, gross faecal soiling, malodour, unsuitable structures, unsuitable space provision, lack of socialisation and stimulation, inadequate exercise facilities, contaminated feed and water provision and gross evidence of vermin harbourage.
